

Privacy Policy

This Policy explains what happens to any personal data that you provide to us, or that we collect from you whilst you visit our site and how we use cookies on this website.

Information That We Collect

We may collect data about you when provided by you via personal, face to face contact and/or email or telephone interactions with employees of BTP. Types of personal data we may hold:

Use of Your Information
